

The Hobby Shop Consignment Policy

The Hobby Shop, located at 1501 Parkwood Blvd. Suite #245 (Wilson Mall) in Wilson, NC, has a strong and competitive consignment policy, which allows our customers to sell comic books, collectible toys, artwork or sculptures using The Hobby Shop's store space for a reasonable return.

Our consignment policy is as follows:

1. The consignor will provide The Hobby Shop with a list of consignment items, including a requested selling price for each item. Consignor is aware that The Hobby Shop may offer a discount of up to 20% off this suggested selling price. If the requested selling price is not given, The Hobby Shop may set a selling price at their discretion. The Hobby Shop may suggest reducing a requested selling price or refuse a consignment if the requested selling price seems unreasonable in the opinion of the store.
2. Consignment takes place in a two-month term. Consignment items may not be taken off consignment during this two-month term. Any items not sold after the two-month initial term will be picked up by the consignor, and consignor will have an additional two weeks from the expiration date to pick up their unsold items. Alternately, consignors may choose to enter into another two-month term to sell remaining items, at the discretion of the consignor and The Hobby Shop. In the event that no second term is sought, and the two-week grace period has passed, any items remaining will become property of The Hobby Shop.
3. The Hobby Shop will contact consignor when their item sells, provided the consignor has provided accurate contact information. The Hobby Shop is not responsible for contacting a consignor if they did not provide accurate information. Payment for consigned items that sell will be in the form of check or store credit.
 - a. In the case of checks, the consignor is responsible for picking up his/her own check, unless a self-addressed stamped envelope is left with The Hobby Shop. Any check for items sold which is not picked up and cashed by the consignor within six months of issue will become property of The Hobby Shop. Checks are cut and issued each month on the first day of the month.
 - b. In the case of store credit, credits are processed each month on the first day of the month. Any store credit not used by the consignor within one year of issue will become the property of The Hobby Shop.
4. Item display and placement is at the sole discretion of The Hobby Shop.
5. The Hobby Shop shall not be liable for any damage or destruction of items, however caused, provided that The Hobby Shop has used reasonable care in keeping the item entrusted to it. In the case of lost or stolen items, the consignor will be refunded 70% of the requested sale value of the items. The items must appear on the consignor's list of consignments, with the initials of a Hobby Shop employee appearing in the "verified" column of the form, as proof that The Hobby Shop accepted the items.

6. The Hobby Shop agrees to act as your agent in the sale of the property listed on the Consignment Items List.
 - a. If you commission The Hobby Shop to sell your items in store only at the price you requested less any discounts agreed upon you will pay The Hobby Shop a commission of 30% with the remaining 70% of the selling price being paid to you, the consignor in manner stated below.
 - b. If you commission The Hobby Shop to sell your items in the store and on our website at the price you requested less any discounts agreed upon you will pay The Hobby Shop a 25¢ pre item non-refundable digital imaging fee, plus commission of 30% with the remaining 70% of the selling price being paid to you, the consignor in manner stated below. Digital imaging fees must be paid at the time the consignment items are received by The Hobby Shop.
 - c. If you commission The Hobby Shop to sell your items in the store, on our website and in our eBay store at the price you requested less any discounts agreed upon you will pay The Hobby Shop a 25¢ per item non-refundable digital imaging fee, an Ebay listing fee of \$2.00 per item up to \$49.99, \$3.00 per item for items \$50.00 - \$99.99, \$4.00 per item for items \$100.00 - \$499.99, and \$5.00 per item for items \$500.00 and over, plus a commission of 35% with the remaining 65% of the selling price being paid to the consignor in manner stated below. Digital imaging fees and eBay listing fees must be paid at the time the consignment items are received by The Hobby Shop.
7. A signed copy of this consignment policy must accompany all consignments accepted by The Hobby Shop.
8. This agreement is governed by the laws of the State of North Carolina, and both parties agree that the extent any court actions has to be taken by either party resulting from the consignment of any goods that said action will be brought in a court of competent jurisdiction within the State of North Carolina.
